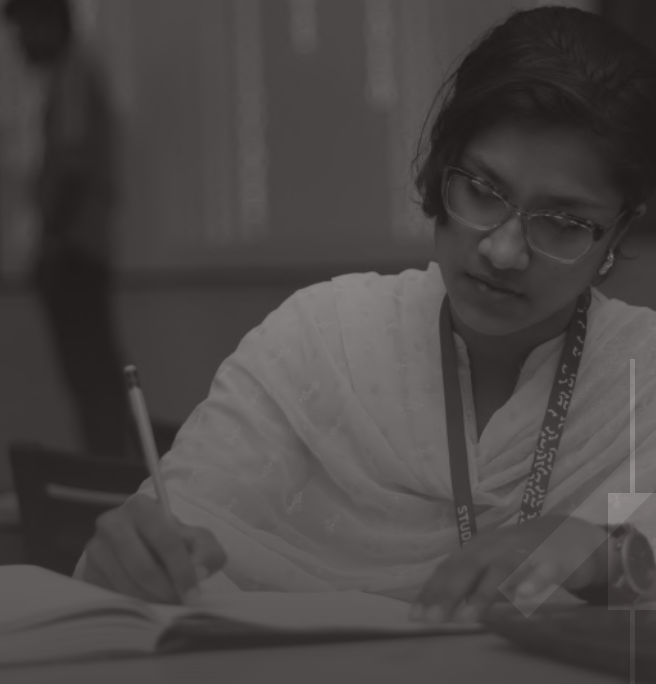

IB Board - Must have 3 HL and 3 SL with 24 credits. GCE / Edexcel - Must have a minimum of 3 A levels grade not less than C.
